Condition On Admission

The patient's chief complaint was of numbness in her left limbs for the previous 5 years. Upon admission she was found to have numbness in her left limbs without any loss of power and the muscle tension was also normal. She also suffered from headaches. Her visual field and power were normal.

Treatment Schedule

Patient received 6 umbilical cord blood-derived stem cell (UCBSC) packets by intravenous (IV) injection and lumbar puncture (LP) as per schedule below:

Condition On Discharge
